Discount Soft Water PLATINUM Package water softener resin is warranted by Discount Soft Water to be free from defects in materials and workmanship under normal use within the service and operating parameters listed below for a period of the lifetime of the purchaser from the date of Installation. Discount Soft Water PLATINUM Package purifier carbon is warranted by Discount Soft Water to be free from defects in materials and workmanship under normal use within the service and operating parameters listed below for a period of the lifetime of the purchaser from the date of Installation. United Waterworks LLC will provide labor under said warranty at no charge for 1 years from the date of Installation. The Discount Soft Water PLATINUM water softener should be inspected and serviced with the UnitedCare POINT PLUS maintenance plan on an annual basis. This limited warranty will not transfer from the original purchaser or the original location of installation. Discount Soft Water under this limited warranty shall be limited, at its option, to replace or repair of any system(s) covered by this Limited Warranty. No warranty is made with respect to defects not reported to Discount Soft Water within the warranty period and/or defects or damages due to neglect, misuse, alterations, accident, misapplication, physical damage, or damage caused by fire, acts of God, freezing or hot water or similar causes. For outdoor installations where the system(s) are not under cover, a weather cover must be utilized for the warranty to be valid.
